1. THE BUSINESS: *(Australian Karting Association Inc., Australian Karting Association (NSW) Inc, Australian Karting Association (WA) Inc, Victorian Karting Association Inc, Australian Karting Association (SA) Inc, Australian Karting Association (TAS) Inc, NT Karting Association Inc, Australian Karting Association (QLD) Inc, including all affiliated and associated clubs, their Committees, Sub-Committees, Members, Trustees, Licensed Holders, Officials, Volunteers and Employees, The CEO, Secretariat, National Karting Council.*

2. THE ACTIVITY: Principally administrators, organisers & promoters of sprint kart events including official practice and come & try days

3. THE RISKS OF THE ACTIVITY:

- Risk of being hit by a kart
- Risk of being hit by debris from a kart
- Risk of being burnt
- Risk of crashing a kart into safety barriers & fencing
- Risk of crashing due to the surface of the track
- Risk of crashing due to debris being on the track
- Risk of slipping and falling due to the surface of the pits, track or restricted areas
- Risk of crashing into another kart
- Risk of crashing due to mechanical failure of the kart
- Risk of another kart crashing into my kart

4. MEDICAL DISCLOSURE: *(fully set out the Official' s medical or other conditions that may be relevant to the performance of the Activity)*

5. ACKNOWLEDGEMENT

1. I acknowledge that:

- (a) I am the participant/I am a parent or guardian of the Minor.
- (b) I/The Minor am/is being supplied with a recreational service by the Business.
- (c) The Activity is a dangerous recreational activity which involves a significant risk of physical harm.
- (d) I/The Minor and Parent/Guardian may be injured in performing the Activity.
- (e) My/The Minor's and Parent/Guardian personal property may be lost, damaged or destroyed in performing the Activity.
- (f) Other people may cause me/The Minor and Parent/Guardian injury or may damage my/The Minor's and Parent/Guardian property in the course of performing the Activity.
- (g) I/The Minor and Parent/Guardian may cause injury to other persons or damage their property in performing the Activity.
- (h) The natural conditions in which the Activity is conducted may vary without warning.
- (i) My/The Minor and Parent/Guardian participation in the Activity is voluntary and I/we have not been required by the Business to engage in the Activity.
- (j) I/The Minor and Parent/Guardian have disclosed any pre-existing medical or other condition that may affect the risk that either I/The Minor and Parent/Guardian or any other person will suffer injury, loss or damage.
- (k) The Business relies on the information provided by me/The Minor and Parent/Guardian and I/The Minor and Parent/Guardian state that all such information is accurate and complete.
- (l) I am aware of the dangers associated with the consumption of alcohol, mind altering substance, drug or other substance which may impair my /The Minor and Parent/Guardian judgment or physical ability or capacity to safely participate in the Activity and accept

- (m) This documents records the entire agreement between the Business and I/The Minor and Parent/Guardian in relation to the Activity and my participation in it.
- (n) I/The Minor and Parent/Guardian have not relied upon any advice, representations or inducements by or on behalf of the Business in deciding to participate/allow the Minor to participate in the Activity or in deciding to sign this document.

6. RISK WARNING

- 1. I/The Minor and Parent/Guardian acknowledge that I/we have been warned of the Risks of the Activity.
- 2. I/The Minor and Parent/Guardian acknowledge that the Activity may also involve other risks not noted in the Risks of the Activity listed on page one.
- 3A. The Business has placed signs around the site on which the Activity is to be performed warning of the risk of injury. I/The Minor and Parent/Guardian have read the signs and understand the warnings provided.
- 3B. The Business has provided me with oral warnings of the Risks the Activity and the risks of physical harm in participating in the Activity. .

7. ASSUMPTION OF RISK

- 1. Notwithstanding the significant risks of physical harm and injury inherent in the Activity, some of which are noted above, I/The Minor and Parent/Guardian agree to participate in the Activity at my own risk.

8. WAIVER, RELEASE AND INDEMNITY

- 1. I/The Minor and Parent/Guardian agree that the provisions of Section 74 of the *Trade Practices Act 1974* (Cth) and any similar state legislative provisions (which provide for an implied warranty that services be rendered with due care and skill and that any material supplied in connection with those services will be reasonably fit for purpose) are excluded and do not apply to this contract in so far as they relate to liability for death or personal injury from the Activity.
- 2. I/The Minor and Parent/Guardian agree to release and hold harmless the Business its servants, employees and agents from and against any liability arising out of any injury, loss, damage or death caused to me/The Minor and Parent/Guardian or my property or any other person arising from or in connection with my participation in the Activity whether such injury, loss, damage or death was caused directly or indirectly by negligence, breach of contract or any way whatsoever other than where the injury, loss, damage or death was caused solely by the negligence of the Business, its servants, employees or agents.
- 3. I/The Minor and Parent/Guardian agree to indemnify and hold harmless the Business, its servants, employees and agents from all claims, damages, losses, injuries and expenses arising out of or resulting from my/The Minor and Parent/Guardian participation in the Activity. This indemnification extends to all claims made by/The Minor and Parent/Guardian and any other person against the Business, its servants, employees or agents in respect of any injury, loss or damage arising out of or in connection with my/The Minor and Parent/Guardian participation in the Activity, other than where the injury, loss, damage or death was caused solely by the negligence of the Business, its servants, employees or agents.

9. MISCELLANEOUS

- 1. I/The Minor and Parent/Guardian agree to comply with all rules and directions made or given by the Business in connection with the Activity. I/The Minor and Parent/Guardian understand that if I/we fail to comply with the rules and/or directions of the Business, I/The Minor and Parent/Guardian may be injured or injure someone else. Further I/The Minor and Parent/Guardian understand that I/we will not be permitted to continue the Activity and no refund will be given.
- 2. I/The Minor and Parent/Guardian agree to report all accidents, injuries or loss or damage sustained by me to the Business before I leave the site on which the Activity is performed.
- 3. I/The Minor and Parent/Guardian agree that if I/we suffer any injury or illness I/we agree that the Business may provide or arrange evacuation, first aid and medical treatment at my expense.

I /The Minor and Parent/Guardian ACKNOWLEDGE THAT I/WE HAVE READ THIS FORM AND THAT IT HAS BEEN EXPLAINED TO ME/US.
